Hello,

thank you for your interest in participating in the AniNite 2024 stage program. To ensure that everything runs smoothly during the con, we ask you to adhere to the following guidelines.

SUBMISSIONS

ALL instructions and files must be received by June 30, 12 pm noon at the latest! After that no changes are possible!

What exactly do we need?

- All instructions for light, sound, video; possible options: Dark/light at the beginning, light/dark on cue, color mood, spot in the middle
- Is a rehearsal desired / necessary (please note that this will take at least 30 minutes and will take place in the morning) - only applies to show groups and bands!
- Due to fire safety regulations, all pyrotechnics, fog, etc. are prohibited!
- All stage props must be B1 certified or have B1 certified impregnation. This will be checked
- The actual number of people on stage
- On the day of your performance, you must personally hand in all files on a USB stick to the stage-office at least 2 hours BEFORE your performance; the USB stick will be sealed in an envelope and labeled. These can be collected from the stage-office after your performance. If this does not happen, we cannot guarantee that the performance will go off without a hitch 😊
- With the delivery of a USB stick, final material changes (image / video / sound) are still possible. Changes to lighting and microphones are not possible! Please note that only files for your performance must be on it. If this USB stick or the files on it are damaged, this will result in the originally submitted material being played back.
- Each person must sign directly before his/her performance that he/she has accepted, read and understood the safety regulations/guidelines.

SAFETY REGULATIONS

Any pyrotechnics, fire, fog is prohibited

Cosplay weapons and similarly things are only allowed be brought onto the stage AFTER approval by the weapons control

Only the designated paths on and off the stage may be used to enter or leave the stage, jumping on or off the stage is prohibited!

If your performance includes fast lighting effects or flashing lights, the information or warning for epileptics must be sent out in advance.

The instructions of the stage personnel ('crew') must be followed at all times!

Willful damage to the stage, props and technical equipment falls under the liability of the persons on stage (penalties are possible accordingly the Austrian law: ABGB/StGB).

We thank you for complying with the guidelines and regulations and wish you lots of fun and a great performance.

FILE FORMATS (TECHNICAL SPECIFICATIONS)

Video material (Cosplay/KPOP Dance/....)

Resolution: 16:9, at least 1280x720 bp, ideally 1920x1080 bp

Format: common/contemporary video formats/codecs such as: .mp4, .mkv,...

File size: maximum 150MB/min

Audio material (Cosplay/KPOP/....)

Quality: at least 192kbps/48kHz stereo, VBR allowed.

Format: common/contemporary audio formats: mp3, m4a, ogg, flac

File size: maximum 20MB/min

Image material (Cosplay/KPOP/...)

Quality: At least 800x800 pixels, ideally 1920x1080 and above

Format: .bmp, .jpg, .png, .jpeg

File size: <50M
